Job Summary:

The Arkansas Game and Fish Commission (AGFC) Biological Technician I is responsible for forest and fish propagation, fire prevention, cultivation, and harvesting activities and/or maintaining a wildlife management area. This position is governed by state and federal laws and agency policy.

Typical Functions:

- Inspects forest lands for damage by insects or disease, assists in implementing plans or recommendations for control measures, and prepares plans for site preparation or improvement of planting, harvesting, marketing, or wildlife use
- Conducts or assists in conducting research on collected samples, such as fish, blood, water, soil, and plant species, and examines animals and specimens to detect diseases or other problems
- Conducts agricultural and forest management activities on wildlife management areas, including preparing seed beds and plant foods; selects and marks trees for thinning and/or logging utilizing soil erosion control measures and maintains waterways, dams, and ponds
- Monitors and inspects public and private wildlife to ensure compliance with state regulations and trains various
 personnel in activities, such as fire safety, accident prevention, and maintenance and calibration of scientific and
 technical equipment
- Gathers, provides, and presents general and forestry educational information and training to various federal, state, and local health officers, community organizations, and the general public
- Provides technical support and services for scientists and engineers working in fields, such as agriculture, environmental science, resource management, and biology
- Assists in conducting fish and game propagation and maintenance activities, including monitoring of spawning, hatching, incubation, sexing, and feeding
- Prepares reports pertaining to wildlife findings, conclusions, and recommendations
- Cleans, maintains, prepares, and supplies work areas
- · Performs other duties as assigned

Specific Duties and Responsibilities:

This position educates the public about multiple areas of fish, fishing, and other aquatic flora and fauna found in Arkansas. Outreach efforts include programming for events, school lessons, fishing derbies, clinics, seminars, and public groups. Must have knowledge of native aquatic wildlife and are able to handle and care for live fish and reptiles. Towing a trailer-mounted aquarium with live fish offsite to educate the community is a responsibility. This position will also maintain commission equipment and education animal habitat tanks. This position will serve the public by working with agency staff and partners to promote aquatic education and conservation initiatives.
