POSTING REQUIREMENTS:

Minimum Education and/or Experience:

To be eligible for an AGFC Internship, applicants must meet the following prerequisites:

- Must have 60 hours of college credits earned by the time the Internship begins.
- At the time of application, must be a college student, graduated within the previous 12 months, or currently enrolled in a post-graduate program.
- Must have a 2.5 cumulative grade point average on a 4.0 scale.

Selected intern will coordinate directly with his/her college or university to obtain course credit for their work.

Preferred Education and/or Experience:

- Have a declared degree in a conservation field
- Have 60 hours of college credits earned by the time the internship begins
- At the time of application, must either: be a college student; have had graduated within the previous 12 months; or currently be enrolled in a post-graduate program
- Have a 2.5 cumulative grade point average on a 4.0 scale

Selected interns will coordinate directly with their college or university to obtain course credit for their work

Knowledge, Abilities, and Skills:

Required skills may vary depending on the AGFC position and division. The following skills are typically required for conservation-focused AGFC positions:

- Knowledge of the procedures and methods used in documenting wildlife investigations.
- Knowledge of the equipment and techniques used to maintain buildings, grounds and equipment.
- Knowledge of fish propagation, harvesting, cultivation, and maintenance activities.
- Knowledge of tissue and blood sampling techniques used in collection research.
- Knowledge of agricultural methods and basic land laws.
- Knowledge of timber marking, land surveying, and other related forestry techniques.
- Ability to collect samples of wildlife, perform fish hatchery, prepare reports, maintain files, and present oral and written information.
- Ability to operate and maintain wildlife equipment.

Preferred Knowledge, Abilities, and Skills:

- Skilled in oral and written communication
- General hunting and boating safety knowledge
- Experience with canoes or kayaks, firearms, and archery
- Knowledgeable of native plant and animal species in Northwest Arkansas ecosystems
- General knowledge of education principles and learning concepts
- Ability to coordinate multiple activities with peers, supervisors and volunteers
- Ability to communicate in a public forum
- Ability to handle and care for a variety of native species
- Proficient in various computer software programs.

Job Summary:

The AGFC Internship program is designed to help students gain education and practical experience related to the conservation work AGFC performs and to meet hands-on training requirements necessary for students to earn their degree. This training is critical to students pursuing a conservation career and is often the deciding factor in gaining employment after college.

Typical Functions:

Specific Duties and Responsibilities:

This Internship will be based out of the Springdale Nature Center, but will spend an equal amount of time in the northwest region of four (4) counties. The main "project" for this internship will be to prepare, organize and lead fishing camps which are to be held in at least two counties. These camps are for youth age participants.

The intern will teach fish biology/anatomy, casting techniques & the difference between lures and baits. They will also take the camp participants fishing. Full-time and part-time AGFC staff will assist with this project, but the intern will be responsible for preparing the outline and taking the lead. Additionally, the intern will help with classes held at the Nature Center like Archery and Paddling/Fishing which could also lead to him/her assisting with float trips.

AGFC interns are paid \$13.00 per hour and work approximately 40 hours per week (no more than 400 hours for 10 weeks).

Intern positions will be available through June, July, and August. Flexible work schedules can be established with your division supervisor.
