#### Job Summary:

The Arkansas Game and Fish Commission (AGFC) Biologist II is responsible for supervising wildlife or fisheries management areas. This position is governed by state and federal laws and agency policy.

## Typical Functions:

Plans and conducts various biological surveys to investigate population, habitat, and ecology of game and fish species and conducts studies of game and fish propagation, cultivation, and harvest.

Analyzes and evaluates survey and sampling data and writes reports describing the results of the data and makes recommendations on game and fish populations.

Directs the development of various wildlife management areas or fish propagation and cultivation and treatment plans based on district management plans. Assists supervisor with districts' annual budgetary projections, prepares various reports and purchase orders, requisitions for equipment, supplies, and parts, and prepares monthly activity reports.

Makes presentations to civic groups, schools and clubs, and conducts public meetings to explain new and/or proposed rules and regulations and/or to hear complaints about wildlife management.

Writes articles for news releases on game and fish activities in district.

Assists supervisor in the development of game and fish management plans and proposals to expand or improve management areas.

Performs other duties as assigned.

#### Specific Duties and Responsibilities:

- Provides wildlife technical advice and assistance to landowners, deer management clubs and other leased land managers through state and federal programs
- Coordinates with state and federal agencies, and other conservation organizations to promote wildlife management on private lands via Farm Bill Programs along with other state and non-profit conservation organization programs such as: CSP, RCPP, EQIP, WLFW, CRP, WRP, Forest Stewardship, CIP & Acres for Wildlife
- Coordinates with Private Lands Habitat (PHL) Division program coordinators to help administer conservation programs that promote wildlife management and provide public access to private lands. Programs include DMAP, ARWRICE and Private Lands Dove Field Program.
- Conducts public relations and education activities as assigned to increase and improve habitat creation and
  restoration on private lands using all private lands programs administered by the PLHD. This will include
  hosting at least one Qualified Prescribed Burner workshop in your coverage area and assisting other approved
  instructors from PLHD or Arkansas Forestry Division with additional workshops.
- Provides harvest management recommendations and management plans through the Deer Management
  Assistance Program (DMAP). Provide technical assistance to DMAP clubs on all aspects of deer management
  to clubs enrolled in the DMAP program. Coordinates with NDA Biologists to implement DMAP in their counties.
- Assists APHIS in addressing nuisance animal and wildlife depredation complaints from property owners and provides appropriate technical assistance
- Responsible for keeping current on wildlife and habitat management principles and practices, federal farm bill
  and state habitat funding programs through appropriate use of current professional literature, continuing
  educational workshops and cultivation and maintenance of professional contacts and partnerships to include
  The Wildlife Society.
- Complete appropriate professional development and continuing education. This includes 6/12/18/24 month training benchmarks in the division training curriculum.
- Conducts wildlife population management, research and surveys.
- Performs routine administrative duties required to comply with program, division and agency standards.
- Complete and maintain prescribed fire qualifications by passing a walk test (2 miles, 25 pound pack, under 30 minutes) and classroom refresher

## Certificates, Licenses, or Registrations:

Must possess a valid Arkansas driver's license.

#### Special Job Dimensions:

Frequent in-state travel and field work with exposure to inclement weather is required.

Occasional exposure to hunters and dangerous animals may be required.
